

# Privacy policy relating to the free Wi-Fi network Wifi.Brussels

## 1. Application and acceptance of the privacy policy

The purpose of this document is to explain how IRISnet, manager of the processing of the Wifi.Brussels network, manages the personal data of users of the free Wi-Fi network. This network is offered under the name Wifi.Brussels.

When first accessing the Wifi.Brussels network, the terms of this Privacy Policy must be explicitly accepted, as must the Terms of Use. The privacy policy can be downloaded or printed from the wifi.brussels website (<http://wifi.brussels>).

By using the Wifi.Brussels network and provided you accept this Privacy Policy, you explicitly agree that IRISnet or its trusted service providers may process the personal data described in this document.

## 2. Who is responsible for processing your personal data?

The party responsible for processing your personal data collected in the context of the Wifi.Brussels network offer is IRISnet scrl, having its registered office at 21, Avenue des Arts, 1000 Brussels, registered with the Crossroads Bank for Enterprises under number 0847.220.467 (hereinafter “IRISnet”).

You remain responsible for the content and confidentiality of any information or personal data transmitted when using the Wifi.Brussels network.

## 3. What information about you is collected by IRISnet and why?

IRISnet only collects and further processes the personal data of users of the Wifi.Brussels network when these data are necessary to ensure the connection to the service and the optimal provision of this service, in particular:

- the MAC address of the mobile device you use to connect to the Wifi.Brussels network;
- the e-mail address you provide for your registration to the Wifi.Brussels network;
- The first and last name and nationality that you will provide when you register on the network.

IRISnet:

- Will not use your personal data for purposes other than those described in this Privacy Policy;
- Will not collect personal data contained in the information transmitted when using the Wifi.Brussels network;
- Will not transfer your personal data to third parties, except if the operation of the Wifi.Brussels network requires it or if the competent law enforcement authorities require it through a formal request for compliance with legal obligations.

#### **4. How will IRISnet process your personal data?**

IRISnet processes all personal data diligently and in accordance with applicable data protection laws and regulations.

Your personal data are stored

- Safely and confidentially, in an environment that is not accessible to the public;
- As long as necessary to guarantee the provision of the service and thereafter for a period of one (1) year at each connection.

#### **5. Applicable law and jurisdiction**

This Privacy Policy is governed by Belgian law.

Any dispute that may arise from this Privacy Policy shall be subject to the exclusive jurisdiction of the courts of Brussels.

#### **6. Changes to the Privacy Policy**

The Privacy Policy in force is always the one applicable at the time of connection to the Wifi.Brussels network. Any changes will be published on the Wifi.brussels website (<http://wifi.brussels> ) and must be accepted upon login.
